Only such architects which have a valid COA certificate and relevant experience of 5 years in design and execution of High-Risk Buildings as defined in HBC-2017. The architect shall be required to have completed at least 5 High-Risk projects in the state of Haryana. Further, if required, the committee may formulate its own procedures for empanelment in conformity with the Haryana Building Code-2017 to ensure that the empanelment process functions smoothly.
