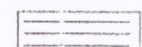

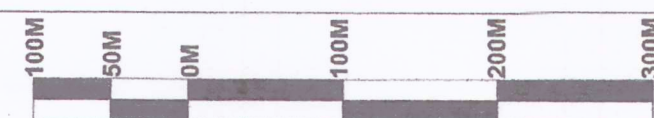


HIGH TENSION LINE SHOWN THUS
